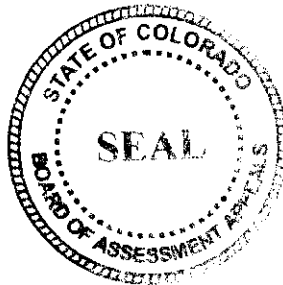

A brief narrative as to why the reduction was made: Analyzed Cost, Market, and Income Information.

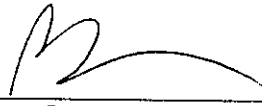
The parties have agreed that the 2006 actual value of the subject property should be reduced as follows:

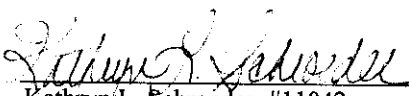
