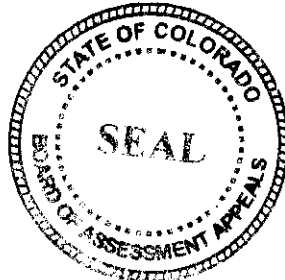

Petitioner and Respondent hereby enter into this Stipulation regarding the tax year 2007 valuation of the subject property, and jointly move the Board of Assessment Appeals to enter its order based on this stipulation.

Petitioner and Respondent agree and stipulate as follows:

1. The property subject to this stipulation is described as:

2. The subject property is classified as residential property.

3. The County Assessor originally assigned the following actual value to the subject property for tax year 2007:

4. After a timely appeal to the Board of Equalization, the Board of Equalization valued the subject property as follows:

5. After further review and negotiation, Petitioner and County Board of Equalization agree to the following tax year 2007 actual value for the subject property:

Total	\$365,637.00


6. The valuation, as established above, shall be binding only with respect to tax year 2007.

7. Brief narrative as to why the reduction was made:


Ms. Iszard met the Assessor's representatives at the property for an interior and exterior inspection. Comparable sales were re-selected based on criteria of cabin-like structures with comparable square footage, age, and heating system. The subject property is at the lower end of average condition for age.


8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on (currently unscheduled) be vacated.
