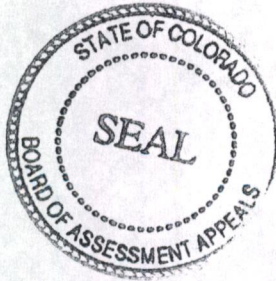

A brief narrative as to why the reduction was made: Analyzed market & income information.


The parties have agreed that the 2007 actual value of the subject property should be reduced as follows:


The valuation, as established above, shall be binding only with respect to the tax year 2007.

Both parties agree that the hearing before the Board of Assessment Appeals be vacated or is unnecessary if one has not yet been scheduled.


