Petitioner and Respondent agree and stipulate as follows:


1. The properties subject to this Stipulation are described as set forth in the County Schedule Numbers on Attachment A to this Stipulation.

5. The valuations, as established on Attachment A, shall be binding with respect to only tax year 2007.


6. Brief narrative as to why the reductions were made: reduction to market value.
