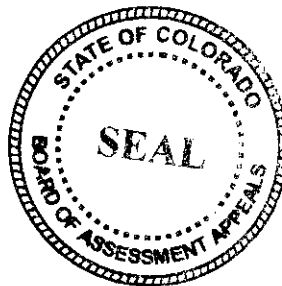

STIPULATION (As To Tax Year 2007 Actual Value)

Petitioner, SLT Aspen Dean Street, LLC, and Respondent Pitkin County Board of Equalization hereby enter into this Stipulation regarding the tax year 2007 valuation of the subject properties, and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

The Petitioner and Respondent agree and stipulate as follows:

1. The properties subject to this stipulation are described as Aspen Residence Club and Hotel Condominiums, the Commercial unit (sch# 19444) and the Hotel unit (sch# 19445) and are identified as Parcel No. 2737 182 85 032 and 2737 182 85 033 respectively in Pitkin County Assessor's Office records.

2. The County Assessor originally assigned the following actual value on the subject property for the tax year 2007:

3. After a timely appeal to the Board of Equalization, the Board of Equalization valued the subject property as follows:

4. After further review and negotiation, the Petitioner and County Board of Equalization agree to the following tax year 2007 actual value for the subject property:




5. The valuation, as established above, shall be binding with respect to tax year 2007 and 2008.

6. Both parties agree that the hearing scheduled before the Board of Assessment Appeals shall be canceled.


7. The parties warrant that the undersigned individuals have the full authority to act on their behalf, and that this stipulation shall be binding on each party to the fullest extent of the law.
