

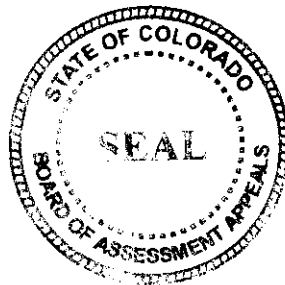

Total	\$1,833,500.00


6. Brief narrative as to why the reduction was made:

Review of market sales indicates stipulated value to be the most appropriate value.


7. The valuation, as established above, shall be binding only with respect to tax year 2007.

8. A hearing has not yet been scheduled before the Board of Assessment Appeals.


