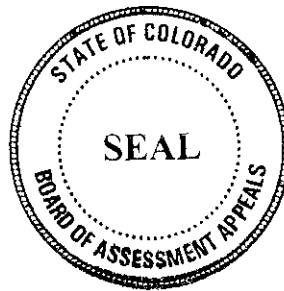

4. After appeal to the Denver County Board of Equalization, the Denver County Board of Equalization valued the subject property as follows:

5. After further review and negotiation, the Petitioner and Denver County Board of Equalization agree to the following actual value for the subject property for tax year 2007.

Total	\$	190,000.00

6. The valuations, as established above, shall be binding only with respect to tax year 2007.

7. Brief narrative as to why the reduction was made:

After further review of the petitioner's comparables it was determined that a valuation reduction was warranted.

8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on October 29, 2008 at 8:30 be vacated.
