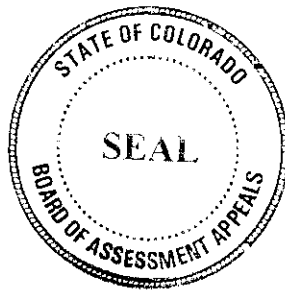

The actual rent rates supplied by the petitioner and the condition of the buildings were considered in adjusting the total value.


8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on December 8, 2008 at 1:00 PM be vacated.
