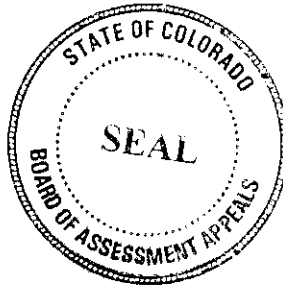

6. The valuations, as established above, shall be binding only with respect to tax year 2007.


7. Brief narrative as to why the reduction was made:

A further review of appropriate market sales indicates a lower value for the subject property.


8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on November 14, 2007 at 10:30 AM be vacated.
