STIPULATION (AS TO TAX YEAR 2007 ACTUAL VALUE)	

Petitioner, DNW, LLC, and Respondent, DENVER COUNTY BOARD OF EQUALIZATION, hereby enters into this Stipulation regarding the tax year 2007 valuation of the subject property, and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

The Petitioner(s) and Respondent agree and stipulate as follows:

1. The property subject to this Stipulation is described as:

Denver, Colorado 80221
2. The subject property is classified as residential property.
3. The County Assessor originally assigned the following actual value on the subject property for tax year 2007.

Land	\$	148,500.00
Improvements	\$	<u>66,300.00</u>
Total	\$	214,800.00

4. After appeal to the Denver County Board of Equalization, the Denver County Board of Equalization valued the subject property as follows:

Land	\$	148,500.00
Improvements	\$	<u>59,500.00</u>
Total	\$	208,000.00

5. After further review and negotiation, the Petitioner and Denver County Board of Equalization agree to the following actual value for the subject property for tax year 2007.

Land	\$	148,500.00
Improvements	\$	<u>35,900.00</u>
Total	\$	184,400.00

6. The valuations, as established above, shall be binding only with respect to tax year 2007.

7. Brief narrative as to why the reduction was made: An 11-27-2008 inspection of the subject property revealed that the subject property did not have a partial basement. The subject property revealed that the subject property was a crawl space only, with access via a trap door in the floor. The Assessor's CAMA record was corrected for 2007 and the property was remarketed with a value of 184,400.00.

8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on 10/10 2008 at 8:30 AM be vacated.
