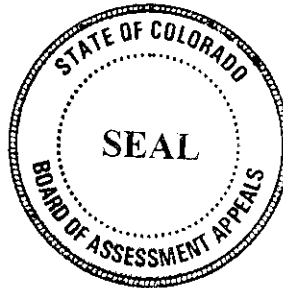

6. The valuations, as established above, shall be binding only with respect to tax year 2007.

7. Brief narrative as to why the reduction was made:

Equal weight was given to the comparable sales presented by both the Assessor and petitioner.

8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on October 27, 2008 at 1:00 PM be vacated.
