5. After further review and negotiation, the Petitioner and Denver County Board of Equalization agree to the following actual value for the subject property for tax year 2007.

6. The valuations, as established above, shall be binding only with respect to tax year 2007.

7. Brief narrative as to why the reduction was made:

A value reduction is warranted based on the raw sale price of the best comparable, Unit 408.

8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on November 21, 2008 at 8:30 AM be vacated.
