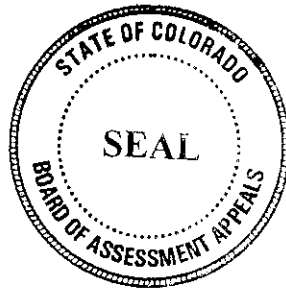

AMENDMENT TO ORDER (On Stipulation)


