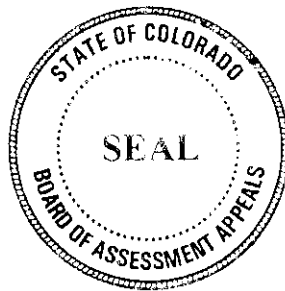

3. The parties agree that the 2007 actual values of the subject property shall be Stipulated Values below:

6. This valuation is for purposes of settlement only and does not reflect an appraised value.
