Respondent is ordered to reduce the 2007 actual value of the subject property, as set forth above.



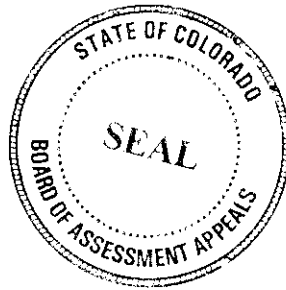

STIPULATION (As to Tax Year 2007 Actual Value)

Petitioner and Respondent hereby enter into this Stipulation regarding the tax year 2007 valuation of the subject property and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

The Petitioner and Respondent agree and stipulate as follows:

1. The property subject to this Stipulation is described as:

Lot 1A, Blk 6 Perry Park East 1, as modified per LLA 2003032187. 5.12 AM/L.

2. The subject property is classified as Residential property.
3. The County Assessor originally assigned the following actual value on the subject property for tax year 2007:

Land	\$220,000
Improvements	\$357,046
Total	\$577,046

4. After a timely appeal to the Board of Equalization, the Board of Equalization valued the subject property as follows:

Land	\$220,000
Improvements	\$357,046
Total	\$577,046

5. After further review and negotiation, the Petitioner and the Douglas County Board of Equalization agree to the following tax year 2007 actual value for the subject property:

Land	\$220,000
Improvements	\$265,000
Total	\$485,000


6. The valuations, as established above, shall be binding only with respect to tax year 2007.

7. Brief narrative as to why the reduction was made:


Based on the sales comparison approach to value, which includes a review and comparative analysis of sales of similar properties in the area, a change in value was warranted.
