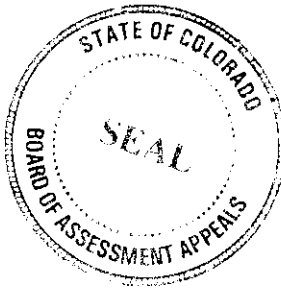

3. The County Assessor originally assigned the following actual value on the subject property for tax year 2007.

4. After appeal to the Denver County Board of Equalization, the Denver County Board of Equalization valued the subject property as follows:

5. After further review and negotiation, the Petitioner and Denver County Board of Equalization agree to the following actual value for the subject property for tax year 2007.

6. The valuations, as established above, shall be binding only with respect to tax year 2007.

7. Brief narrative as to why the reduction was made:

The recognition of the subject's property's 2005 and 2006 actual income resulted in an adjustment to the assigned value.

8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on March 13, 2009 at 8:30 AM be vacated.
