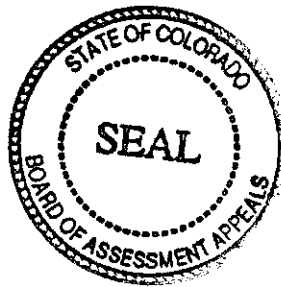

6. The valuations, as established above, shall be binding only with respect to tax year 2007.

7. Brief narrative as to why the reduction was made:

Review of area sales and actual rental information submitted on behalf of the petitioner by his agent, resulted in a revised value estimate. No appeal is on file for 2008.

8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on April 22, 2009 at 8:30 AM be vacated.
