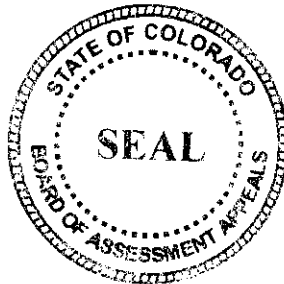

Petitioner and Respondent hereby enter into this Stipulation regarding the tax year 2007 valuation of the subject property and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

The Petitioner and Respondent agree and stipulate as follows:

1. The property subject to this Stipulation is described as:

Unit 82, Bldg. 31, St. Andrews @ Plum Creek Condos Bldg. 31.

2. The subject property is classified as Residential property.

3. The County Assessor originally assigned the following actual value on the subject property for tax year 2007:

7. Brief narrative as to why the reduction was made:


Further review of the sales comparison approach to value, including a review and comparative analysis of similar properties, indicated that a change in value was warranted.
