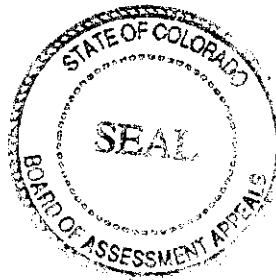

7. Brief narrative as to why the reduction was made:


A full inspection of the subject property, conducted with the petitioner, revealed additional economic obsolescence indicating a reduction in value is warranted.


8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on March 12, 2009 at 4 PM be vacated.
