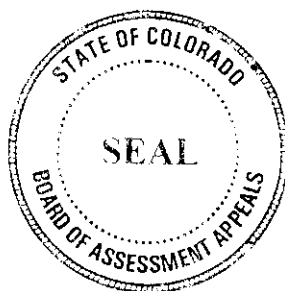

3. The County Assessor originally assigned the following actual value on the subject property for tax year 2007.

4. After appeal to the Denver County Board of Equalization, the Denver County Board of Equalization valued the subject property as follows:

5. After further review and negotiation, the Petitioner and Denver County Board of Equalization agree to the following actual value for the subject property for tax year 2007.

7. Brief narrative as to why the reduction was made:

A full inspection of the subject property, conducted with the petitioner, revealed additional obsolescence indicating a reduction in value is warranted.

8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on February 25, 2009 at 9:30 AM be vacated.
