7. Brief narrative as to why the reduction was made:


New financial data which became available regarding the property's base period operations indicated the need for recognition of less income than was originally projected.


8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on April 24, 2009 at 1 PM be vacated.
