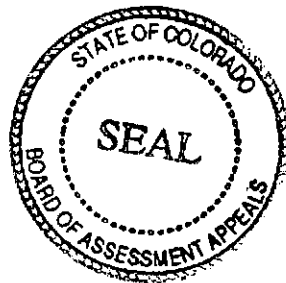

STIPULATION (AS TO TAX YEAR 2007 ACTUAL VALUE)	

Petitioner, SVN YOSEMITE LLC, and Respondent, BOARD OF EQUALIZATION OF THE CITY AND COUNTY OF DENVER, hereby enters into this Stipulation regarding the tax year 2007 valuation of the subject property, and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

The Petitioner(s) and Respondent agree and stipulate as follows:

1. The property subject to this Stipulation is described as:

2. The subject property is classified as commercial property.

3. The County Assessor originally assigned the following actual value on the subject property for tax year 2007.

4. After appeal to the Board of Equalization of the City and County of Denver, the Board of Equalization of the City and County of Denver valued the subject property as follows:

5. After further review and negotiation, the Petitioner and Board of Equalization of the City and County of Denver agree to the following actual value for the subject property for tax year 2007.

Total	\$	6,554,200.00

6. The valuations, as established above, shall be binding only with respect to tax year 2007.

7. Brief narrative as to why the reduction was made:

Hearing timing, staff constraints, and budget limitations of the Assessor's Office compels a capitulation to a value less than the likely market level.

8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on July 7, 2009 at 8:30 AM be vacated.
