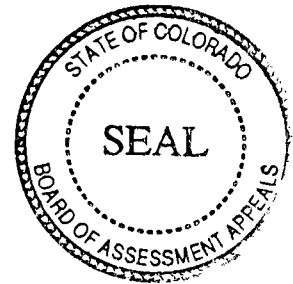

Analysis of subject property's actual income and expense statement indicated a reduction in value is appropriate.


