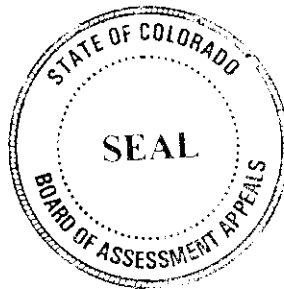

7. Brief narrative as to why the reduction was made:


After an interior inspection of the subject property and review of market data, an adjustment was in order.
