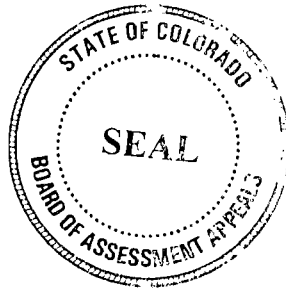

More consideration was made on the submission of the petitioner's actual income information.


