3. The parties agreed that the 2007 actual value of the subject property should be reduced to:

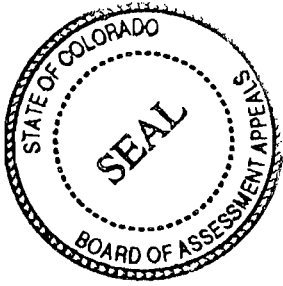
Total Value: \$100,000

STIPULATION (AS TO TAX YEAR 2007 ACTUAL VALUE)

The Petitioner(s) and Respondent agree and stipulate as follows:

1. The property subject to this Stipulation is described as:

2. The subject property is classified as Commercial Warehouse property.

3. The County Assessor originally assigned the following actual value on the subject property for tax year 2007.

4. After appeal to the Denver County Board of Commissioners, the Denver County Board of Commissioners valued the subject property as follows:

5. After further review and negotiation, the Petitioner and Denver County Board of Commissioners agree to the following actual value for the subject property for tax year 2007.

Land	\$	36,000.00
Improvements	\$	<u>64,000.00</u>
Total	\$	100,000.00

6. The valuations, as established above, shall be binding only with respect to tax year 2007.

7. Brief narrative as to why the reduction was made:

The BOCC Hearing Officer reduced the value for 2008. Since no changes had occurred between 2007 and 2008, the value should be the same for the overall evaluation period.

8. Both parties agree to be responsible for their own costs, expert and attorney fees, waiving any claim against each other for such, and agree that any hearing before the Board of Assessment Appeals not be scheduled or be vacated if already scheduled.
