
Petitioner and Respondent hereby enter into this Stipulation regarding the tax year 2008 valuation of the subject properties, and jointly move the Board of Assessment Appeals to enter its order based on this stipulation.

Petitioner and Respondent agree and stipulate as follows:

1. The properties subject to this Stipulation are described as set forth in the County Schedule Numbers on the Attachment to this Stipulation.
2. The subject properties are classified as Vacant Land.
3. Attachment A reflects the actual values of the subject properties:
  - as assigned by the Assessor for tax year 2008; and
  - as assigned by the Board of Equalization for tax year 2008 after a timely appeal; and
  - as agreed to by Petitioner and Respondent for tax year 2008 following further review and negotiation.
4. The valuations agreed to by Petitioner and Respondent, as established on Attachment A, shall be binding with respect to only tax year 2008.
5. Brief narrative as to why the reduction was made: Lot values were changed from a Present Worth valuation to Raw Land valuation.

6. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on April 16, 2009, at 1:00 p.m. be vacated.


