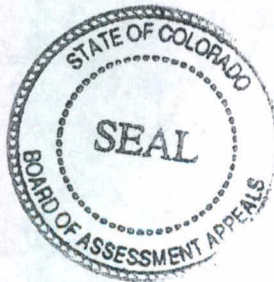

6. The valuations, as established above, shall be binding only with respect to tax year 2008.

7. Brief narrative as to why the reduction was made:

The recognition of the subject property's rental rates, expenses and vacancy resulted in an adjustment to the assigned value.

8. Both parties agree that the hearing not yet scheduled before the Board of Assessment Appeals be vacated.
