Total Value: \$5,000,000

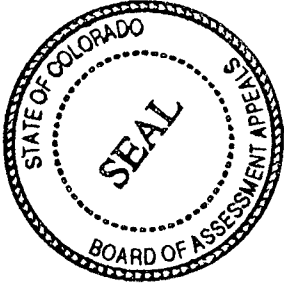

7. Brief narrative as to why the reduction was made:


Further analysis of the subject's operating statements and market sales/rents/warranted a reduction in value.
