Total	\$ 1,550,000.00


6. Brief narrative as to why the reduction was made:

**After physical inspection of the above property and sales analysis of comparable sale properties, the stipulated value better reflects market value as of June 30, 2008.**


7. The valuation, as established above, shall be binding only with respect to tax year 2009.

8. No hearing has been scheduled before the Board of Assessment Appeals.


