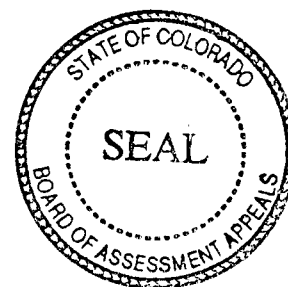

STIPULATION As To Tax Year 2009 Actual Value	

Petitioner and Respondent hereby enter into this Stipulation regarding the tax year 2009 valuation of the subject property, and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

The Petitioner and Respondent agree and stipulate as follows:

1. The property subject to this Stipulation is described as: 1020 Ute Avenue, Grand Junction, Mesa County, Colorado; Schedule Number 2945-144-26-012.
2. The subject property is classified as Residential property.
3. The County Assessor originally assigned the following actual value on the subject property for tax year 2009:

4. After a timely appeal to the Board of Equalization, the Board of Equalization valued the subject property as follows:

5. After further review and negotiation, Petitioner and Respondent agree to the following tax year 2009 actual value for the subject property:


Land	\$52,000.00

6. The valuation, as established above, shall be binding only with respect to tax year 2009.


7. Brief narrative as to why the reduction was made: After an inspection of the subject property, an adjustment was made due to the correction of some inventory items as well as the quality from average to below average.
