**Total Value:            \$305,000**

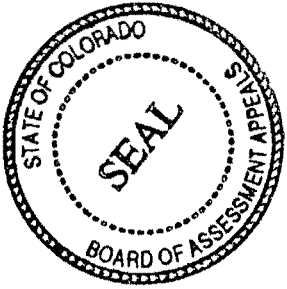

Residential Condominium: \$ 305,000


5. The valuation, as established above, shall be binding with respect to tax year 2009 and 2010.


