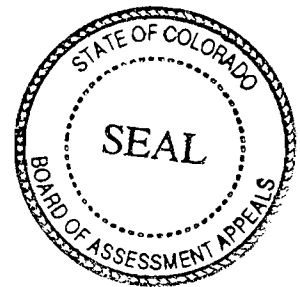

Petitioner, Greg W. and Jennifer K. Long, and Respondent Pitkin County Board of Equalization hereby enter into this Stipulation regarding the tax year 2009 valuation of the subject property, and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

The Petitioner and Respondent agree and stipulate as follows:

1. The property subject to this stipulation is described as SAMUELSON Lot: 13 Tract: 64 Section: 21 Township: 8 Range: 86 PARCEL OF LAND IN TRACT 64 OF SEC 21-8-86 DESC BY M/B in BK 350 PG 739 of Pitkin County Records, and is identified as Parcel No. 2467 212 02 001 in Pitkin County Assessor's Office records.

2. The County Assessor originally assigned the following actual value on the subject property for the tax year 2009:

5. The valuation, as established above, shall be binding with respect to tax year 2009 and 2010.


6. Both parties agree that the hearing scheduled before the Board of Assessment Appeals shall be canceled.


