Petitioner, Aspen Legacy Holdings, LLC, and Respondent Pitkin County Board of Equalization hereby enter into this Stipulation regarding the tax year 2009 valuation of the subject property, and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

The Petitioner and Respondent agree and stipulate as follows:


4. After further review and negotiation, the Petitioner and County Board of Equalization agree to the following tax year 2009 actual value for the subject property:


Vacant Land: \$6,750,000

5. The valuation, as established above, shall be binding with respect to tax year 2009 and 2010.


6. Both parties agree that the hearing scheduled before the Board of Assessment Appeals shall be canceled.
