3. The parties agreed that the 2009 actual value of the subject property should be reduced to:

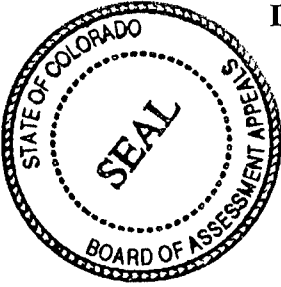
Total Value: \$97,500
