4. After a timely appeal to the Board of Equalization, the Board of Equalization valued the subject property as follows:

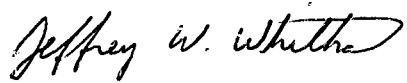
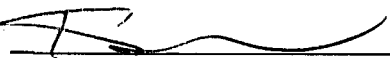
