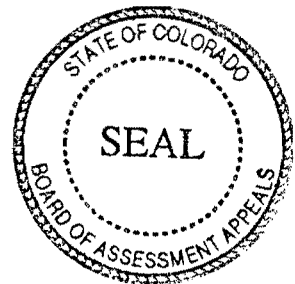

STIPULATION (As To Tax Year 2009 Actual Value)

Petitioner, John W. S. and Monika Preston, and Respondent Pitkin County Board of Equalization hereby enter into this Stipulation regarding the tax year 2009 valuation of the subject property, and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

The Petitioner and Respondent agree and stipulate as follows:

1. The properties subject to this stipulation are described as Wildcat Ranch Homestead 9, portion in Town of Snowmass Village (sch# R013465) and Wildcat Ranch Homestead 9, portion not in Town of Snowmass Village (sch# R015375), and are identified as Parcel No. 2645 232 10 001 in Pitkin County Assessor's Office records.

2. The County Assessor originally assigned the following actual value on the subject property for the tax year 2009:

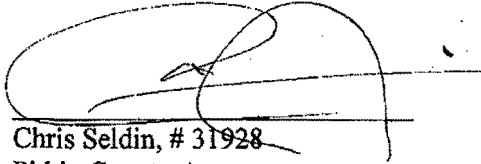
4. After further review and negotiation, the Petitioner and County Board of Equalization agree to the following tax year 2009 actual value for the subject property:

	Total value for parcel	\$18,000,000

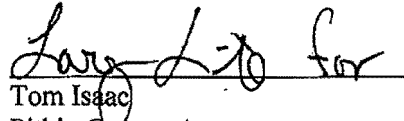
5. The valuations, as established above, shall be binding with respect to tax year 2009 and 2010.
