1. The property subject to this Stipulation is described as:

4. After a timely appeal to the Board of Equalization, the Board of Equalization valued the subject property as follows:

5. After further review and negotiation, Petitioner(s) and County Board of Equalization agree to the following tax year **2009** actual value for the subject property:


