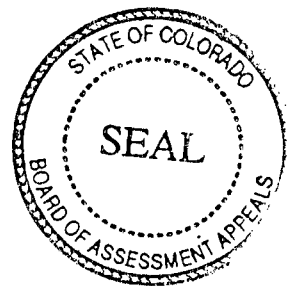

Petitioner, WILHELM HORRIX, and Respondent, BOARD OF EQUALIZATION OF THE CITY AND COUNTY OF DENVER, hereby enters into this Stipulation regarding the tax year 2009 valuation of the subject property, and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

The Petitioner(s) and Respondent agree and stipulate as follows:

1. The property subject to this Stipulation is described as:

 Denver, Colorado 80205
2. The subject property is classified as a Condo Unit.

3. The County Assessor originally assigned the following actual value on the subject property for tax year 2009.

Land	\$	44,700.00
Improvements	\$	<u>533,300.00</u>
Total	\$	578,000.00

4. After appeal to the Board of Equalization of the City and County of Denver, the Board of Equalization of the City and County of Denver valued the subject property as follows:

Land	\$	44,700.00
Improvements	\$	<u>364,300.00</u>
Total	\$	409,000.00

5. After further review and negotiation, the Petitioner and Board of Equalization of the City and County of Denver agree to the following actual value for the subject property for tax year 2009.

Land	\$	44,700.00
Improvements	\$	<u>305,300.00</u>
Total	\$	350,000.00

6. The valuations, as established above, shall be binding only with respect to tax year 2009.

7. Brief narrative as to why the reduction was made:

After reviewing the two base period sales from the subject complex and an additional comp from a competing complex with a basement area like the subject. The Assessor's Comp., Unit #401 in the subject complex was overstating the value of the subject.

8. Both parties agree to be responsible for their own costs, expert and attorney fees, waiving any claim against each other for such, and agree that any hearing before the Board of Assessment Appeals not be scheduled or be vacated if already scheduled.
