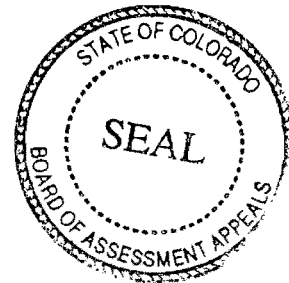

7. Petitioner(s) agree(s) to waive the right to a Board of Assessment Appeals hearing and any further appeal of the schedule numbers: 075911 for the assessment years (s) covered by this Stipulation.
