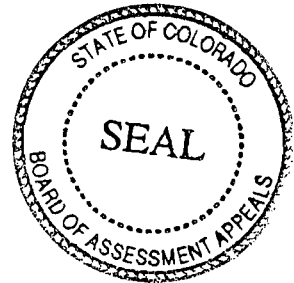

7. Brief narrative as to why the reduction was made:


A reasonable agreement was negotiated between parties.


