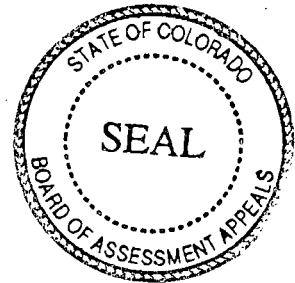

7. Brief narrative as to why the reduction was made:


The subject was field inspected in order to assess physical deterioration and functional obsolescence.
