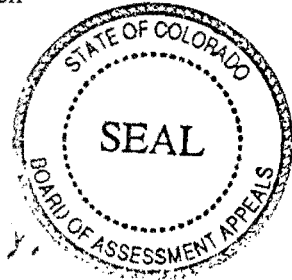

6. The valuations, as established above, shall be binding only with respect to tax year 2009.

The value was adjusted after review of the condition of the subject improvements and actual income and expense levels.

8. Both parties agree to be responsible for their own costs, expert and attorney fees, waiving any claim against each other for such, and agree that any hearing before the Board of Assessment Appeals not be scheduled or be vacated if already scheduled.
