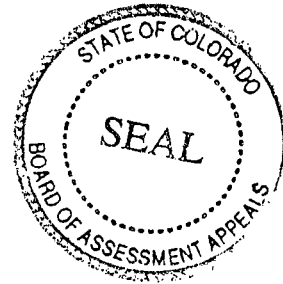

Based on reviewing relevant market data, \$47,000 appears to be a more suitable value for the subject property.


