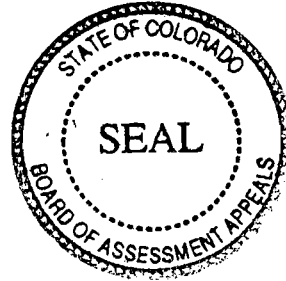

After further review, an adjustment was warranted.


