6. The valuations, as established above, shall be binding only with respect to tax year 2009.


7. Brief narrative as to why the reduction was made:

The value on this property was adjusted during the 2010 appeal period. By law, the 2009 and 2010 values must be the same unless an unusual condition was present which it was not.


