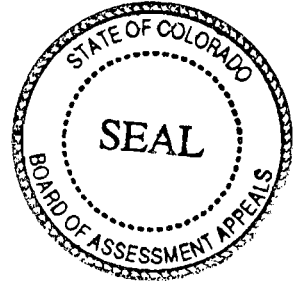

7. Brief narrative as to why the reduction was made:


The base period data available for the subject property, operating statements, vacancy, and capitalization rates, were re-visited and it was determined that a lower value was indicated.
