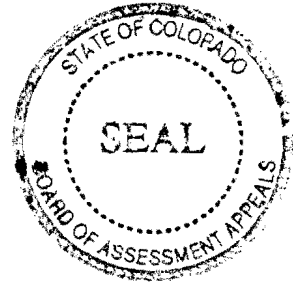

Per further review of market data and comparable sales, a reduction was made.


