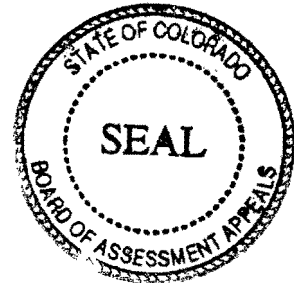

The parties have agreed that the 2007/2008 actual value of the subject property should be reduced as follows:


