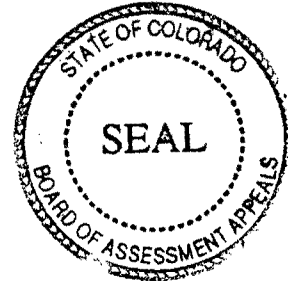

A brief narrative as to why the reduction was made: Analyzed market and income information.


The parties have agreed that the 2008 actual value of the subject property should be reduced as follows:


